



Engage for Good - CARS Contest

GUESS THE DONATION VALUE! - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The GUESS THE DONATION VALUE contest begins on May 31, 2017 and ends on June 1, 2017 at the end of the Engage for Good conference. Winners will be announced during the closing session on June 1.

2. **ELIGIBILITY:** Open to all who are ELIGIBLE MINIMUM AGE of 18. CARS and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising, and promotion agencies and each of their respective officers, directors and employees, are ineligible to enter the Content Sweepstakes or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. In the event of a tie, one winner will be chosen at random for the tie breaker. The decision of the tie break will be final.

4. HOW TO ENTER: Enter the Contest Sweepstakes during the Promotion Period online by visiting the entry form, which can be found on the following website at careasy.org/engageforgood.

Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant's Entries and that Entrant may be disqualified.
